In regard to the 2023 Personnel Adjustment of the Administrative Enforcement Authority of the Ministry of Justice, the list of approved adjustments is as follows, and all adjusted personnel shall report for duty at the newly adjusted authority on August 30, 2023 except prosecutors who are transferred to the District Prosecutors Office after completing rotation at the Taiwan High Prosecutors Office who shall do so on August 31, 2023:

- I. Yeh, Tzu-Chiang, Director of the Taipei Branch, Administrative Enforcement Agency of the Ministry, shall be promoted to Deputy Director-General of the Administrative Enforcement Agency of the Ministry.
- II. Yang, Hsiu-Chin, Director of the New Taipei Branch, Administrative Enforcement Agency of the Ministry, shall be transferred to be the Director of the Taipei Branch, Administrative Enforcement Agency of the Ministry.
- III. Huang, Li-Wei, a prosecutor who will be transferred to the Taiwan Taipei District Prosecutors Office after completing rotation at the Taiwan High Prosecutors Office, shall be transferred to be the Director of the New Taipei Branch, Administrative Enforcement Agency of the Ministry.
- IV. Wu, Tso-Yen, Director of the Tainan Branch, Administrative Enforcement Agency of the Ministry, shall be transferred to be the Director of the Taichung Branch, Administrative Enforcement Agency of the Ministry.
- V. Chang, Yung-Chih, Director of the Kaohsiung Branch, Administrative Enforcement Agency of the Ministry, shall be transferred to be the Director of the Tainan Branch, Administrative Enforcement Agency of the Ministry.
- VI. Yang, Pi-Ying, Director of the Pingtung Branch, Administrative Enforcement Agency

of the Ministry, shall be transferred to be the Director of the Kaohsiung Branch, Administrative Enforcement Agency of the Ministry.

VII. Ko, Yi-Ju, a prosecutor who will be transferred to the Taiwan Shilin District Prosecutors Office after completing rotation at the Taiwan High Prosecutors Office, shall be transferred to be the Director of the Pingtung Branch, Administrative Enforcement Agency of the Ministry.

The personnel adjustment and selection of the Deputy Director-General of the Administrative Enforcement Agency, Ministry of Justice and the Directors of each relevant Branch were approved by the Minister today (August 4, 2023). Minister Tsai, Ching-Hsiang of the Ministry of Justice, with the principles of selecting those with capabilities and assigning them to where their capabilities may develop and for the purposes of activating talent exchange among affiliated authorities under the Ministry of Justice and facilitating overall development of the administrative enforcement system, made these arrangements of office adjustment, selecting outstanding colleagues in the field of administrative enforcement and prosecutors to take up new offices.

In particular, the current Director of the Taipei Branch, Yeh, Tzu-Chiang, who has previously served as the Director of the Yilan Branch, the Chief Secretary of the Administrative Enforcement Agency, and the Director of the Kaohsiung Branch, has contributed a lot by achieving remarkable performance and accumulating comprehensive experiences in the enforcement business for many years. He is a qualified attorney and is promoted to Deputy Director-General of the Administrative Enforcement Agency this time as the first one promoted to Deputy Director-General from the administrative enforcement system. The original Director of the New Taipei Branch, Yang, Hsiu-Chin, has served as the Director for many years, achieving outstanding performance in the overall business and leading the New Taipei Branch to win the 2020 Records Management Quality Awards. She is thus transferred to be the Director of the Taipei Branch. The original Director of the Tainan Branch, Wu, Tso-Yen, properly used arrest, custody, and other enforcement measures against malicious obligors who refuse to make payment when handling

commissioned cases from the prosecutors authority and achieved remarkable performance. He is thus transferred to be the Director of the Taichung Branch. The original Director of the Kaohsiung Branch, Chang, Yung-Chih, in line with important policies recently carried out by the Ministry of Justice and the Administrative Enforcement Agency, actively handled cases in respect of epidemic prevention, African Swine Fever, traffic violations, and drunk-driving punishments, all of which achieved good performance. He is thus transferred to be the Director of the Tainan Branch. The original Director of the Pingtung Branch, Yang, Pi-Ying, achieved outstanding performance in the overall business, led colleagues to creatively prepare for the records management evaluation, and well utilized social media to promote administrative enforcement business with outstanding performance. She is thus transferred to be the Director of the Kaohsiung Branch.

Additionally, in order to increase the prosecutors' administrative experience, cultivate leaders among prosecutors, and encourage earnest and diligent prosecutors, transfer is also made this time for well-educated-and-trained prosecutors to take up Directors' offices.

They are:

1. The prosecutor who is currently on rotation at the Taiwan High Prosecutors Office (three-year rotated prosecutor), Huang, Li-Wei, will return to the Taiwan Taipei District Prosecutors Office after completing rotation this year. He was enrolled in the 39th term of the Academy for the Judiciary, having previously served as the prosecutor for the first instance and the chief prosecutor, was temporarily transferred to the Investigation Bureau, Ministry of Justice as the director of the Civil Service Ethics Office, and is thus experienced in handling practical cases and administrative matters. During his rotation at the second instance, Huang, Li-Wei was responsible for establishing the Technological Monitoring Center and the Technological Investigation Center, setting up the drug knowledge base, planning and expanding information interfacing of the technology-supportive investigation platform, optimizing and upgrading tools and software for digital forensics and cryptocurrency analysis, preparing for the digital forensics environment and introducing the international certification of ISO/IEC 17025

into the Digital Forensics Laboratory. He has double backgrounds both in law and technology and receives praise from all for his expertise and dedication to work. In order to acknowledge his outstanding performance, continue to rely on his profession, and increase his experience, Huang, Li-Wei is promoted to Director of the Administrative Enforcement Agency to facilitate its business advancement and digital transformation.

2. The prosecutor who is currently on rotation at the Taiwan High Prosecutors Office (three-year rotated prosecutor), Ko, Yi-Ju, will return to the Taiwan Shilin District Prosecutors Office after completing rotation this year. She was enrolled in the 40th term of the Academy for the Judiciary and has previously served as the prosecutor for the first instance and the chief prosecutor. During her rotation at the second instance, Ko, Yi-Ju was responsible for national security cases and served as the executive secretary for administrative matters in the teams of fight against crimes interfering with the development of the green energy industry, drug abstinence therapy, and drug re-addiction prevention at the Taiwan High Prosecutors Office. She was good at communications and coordination, was accountable for works, quickly established a liaison platform and completed relevant procedural guidelines, actively completed each administrative matter as assigned, and achieved outstanding performance with leadership talent. In order to increase her administrative experience, Ko, Yi-Ju is promoted to Director of the Administrative Enforcement Agency to facilitate its policy implementation and relevant matters.

The above personnel adjustment is not only to show promotion opportunities for administrative enforcement colleagues but also to implement the policy under which the Ministry of Justice will promote outstanding prosecutors from the prosecutors authority to take up office as the authority's heads. By talent exchange and experience sharing, the administrative enforcement system will again achieve good performance with new blood in respect of enforcement.
