

In 2025, the Chiayi Branch, Administrative Enforcement Agency collected NT\$1056.56 million, an increase of NT\$58.51 million compared with 2024. Of the total amount, the collection from financial and tax cases accounted NT\$408.16 million, or 38.6%. It was followed by NT\$216.20 million from healthy insurance cases , NT\$201.14 million from fine payment cases and NT\$231.06 million from fee payment case . The last three items accounted for 20.5%, 19.0%, and 21.9% respectively.
